It is requested that the overall expenditure be restricted within the allocations made and accordingly the sub allocation be made to the lower formations under intimation to CGHQ, PCDA (Navy), Mumbai and concerned Account Offices at the earliest. The allocation under object head 'Office Expenses' to RHQ(W) and RHQ(E) is also towards Embarkation HQs (Mumbai/Chennai) and for RHQ(W) towards INMARSAT bills. The allocation of funds under object heads 'Advertisement & Publicity' and 'Information Technology' for CGC(ES) are included within the allocation of RHQ(E).
4. The Principal Directors / Directors at CGHQ, RHQs and ICGS Delhi are requested to continue to render submission of fortnightly expenditure returns for fortnight ending 15th and 31st of every month by 20th of the same month and 5th of the ensuing month respectively.
5. Directorates at CGHQ and RHQs are requested to carry out the booking as well as monitoring the bill clearance, imprest audit by respective CDAs on fortnightly basis for reflection of the same in overall CGDA compilation.
6. Based on the RE 2017-18 allocation under the various object heads, as mentioned above, the funds need to be identified and required to be placed with concerned PCDA/ PCDA (HAL)/ CDA/ CDA(AF)/ JCDA/ DCDA/ AO/ EHQs through promulgation so as to facilitate smooth processing of bills and booking of funds.
7. It is, therefore, requested that the quantum of funds to be placed with concerned PCDA(N)/ PCDA (HAL)/ PCDA HQ/ CDA(AF)/ CDAs/ JCDAs/ DCDA/ AOs/ Embarkation HQs under each object heads as per the sub-allocation made to the CG units within jurisdiction of these Account Offices be intimated to CGHQ by 29 Jan 2018 (AM) positively to facilitate promulgation of CDA-wise allocation on RE 2017-18 allocation to avoid non-clearance of bills due to paucity of funds.
8. It is further requested to ensure 100% expenditure of the allocated funds. Any savings to be surrendered by end Feb 2018.
