office letter No.AN/III/3012/Circular/Vol.VIII/Covid dated 29.04.2020 is attached herewith.
The Officer in Charge of Sub Office/Section concerned should ensure the following :-

- All officers/Staff working under them should install Arrogya Setu App in their mobile phones immediately.
- Before starting to office they must review their status on Arrogya Setu App and commute only when the App shows **Safe or Low Risk staus**.
- The officers/staff may be advised that in case the App shows that he/she has moderate or high risk calculated on the basis of Bluetooth proximity, he/she should not come to office and self isolate for 14 days or till status becomes safe or low risk.

The above may be brought to the notice of all concerned for strict compliance.
